

2015 AQUA PARDS Birthday Party Rental Agreement

When:

- Friday Nights from 6PM-8PM
- Parties will begin Friday May 1st, 2015 and end on Friday August 7th, 2015

Rental Includes:

- Fully certified Lifeguard Staff
- Colored wristbands identifying your party
- Birthday boy/girl will receive an AOUA PARDS souvenir cup
- AQUA PARDS will be closed to the general public but you will share the water park with up to 7 other parties

Pricing:

- \$200 (1-29)
- \$250 (30-39)
- \$300 (40-49)
- \$350 (50-59)
- \$25 EXTRA for Private Pavilion
 - o (Total number of guests REGARDLESS if they will be in the water)
 - o If your guest count exceeds the package you paid for, the amount for the next package will be deducted from your deposit
 - o Infants will not be included in guest count

Payment Deadlines:

- All bookings must be paid in full by the Wednesday of your party week
- Check payments are only accepted up to 2 weeks prior to your party date
- Debit cards, Credit cards and money orders are accepted at all times
- NO CASH payments accepted

Food:

- Food will be available for purchase at the concession stand during your party
- A menu is available with prices and package options
- Please fill out the concession form and turn it in with your rental contract
- All party packages must be completed and paid in full by the Wednesday of your party week
- Extra pizzas will not be sold during party
- You MAY bring a Birthday Cake, plates, napkins and eating utensils ONLY (We do not have a refrigerator to store your cake)

Reserved Party Area:

- There will be no more than 8 (including Pavilion Area) parties on the premises during each party date
- Party Areas will be given out on first-pay basis

Upgrades:

- If you have a date booked and realize that you need to add more guests, you must pay for the upgrade before the rental date
- Packages are sold "as is". Refunds will not be given if you booked a larger package than the number of actual attendees

Wristbands:

• All guests will receive a colored wristband upon entrance which will identify them with their assigned group

Example of Rental Package for 29 people:

\$200 (\$100 is your Booking Deposit) + \$100 (Damage Deposit) = \$300 TOTAL COLLECTED

- Booking Deposit-\$100:
 - o Assures your date and area is reserved
 - o If you cancel the event, PARDS will keep the booking fee of \$100
- Damage Deposit-\$100:
 - May be used to offset guest fees over the booked number
 - Will be returned as long as the area is left clean and without damages
 - You may claim your Damage Deposit one week after the event

Rain Outs:

- If, on the rental day, the weather appears to be bad for parties, PARDS will make its' best effort to contact you in a timely matter and re-schedule the party for another day
- The rain out* options include:
 - o Re-schedule the party for an available Friday in the future
 - o Cancel the party and receive a full refund
 - o Book the Pavilion Area for 2 hours during normal operating hours
- If the weather gets bad during your party and there is a "rain out", the following rules will take effect:
 - o If the "rain out" occurs within the first hour (before 7PM), a FULL refund will be given
 - o If the "rain out" occurs after the first hour (7-8PM), there will be no compensation given

*Rain outs include Thunder and Lightning

EXTRA INFO:

- Party host (plus 1) can arrive at 5:45PM to set up and decorate their area
 - o Glitter and small sized decorations are NOT permitted
- Invite guests to arrive 5-10 minutes early for parties so we may place wristbands on them
- Guests may NOT enter water until the designated start time of their party
- Only USCG approved flotation devices will be allowed inside. NO ARM FLOATIES!
- Please do not bring any toys into park, which include but are not limited to: water guns, balls, diving sticks or rings, floating tubes, and/or inner-tubes
- No outside furniture of any type
- PROPER swim attire must be worn by ALL guests that plan on entering the water

*If at any time, you and/or your party feel that AQUA PARDS is not meeting your standards and/or expectations, please notify a STAFF member or SUPERVISOR on duty. These rules are implemented to ensure the highest level of safety for your party and our STAFF so that everyone can enjoy AQUA PARDS. Thank you for your patronage.

ALL RULES of AQUA PARDS apply to rentals.
