## RENTAL INCLUDES:

- Private 20' X 20' covered pavilion area

## PAVILION RATES:

- \$25/hour (2 hour minimum)
- Time Slots Available:
  - o Monday-Saturday: 10AM-12PM/12:30PM-2:30PM/3PM-5PM
  - o Sunday: 12PM-2PM/2:30PM-4:30PM

\*Advanced reservations are requested, but same-day rentals will be allowed if space is available.

## PAYMENT DETAILS:

- Full payment is required at time of reservation. This payment is NON-REFUNDABLE unless reservation is cancelled by PARDS.
- ADVANCED Rental:** Made at Front Desk @ PARDS Fitness & Aquatics Center. Checks are accepted made at least 1 week in advance. Debit cards, credit cards, and money orders are accepted. NO CASH! \*A 3% Fee will be charged for any Credit card transactions.
- Same-day Rental:** Made at Ticket Booth @ AQUA PARDS. CASH, debit and credit cards are accepted.

## RULES:

- All guests MUST pay regular admission into AQUA PARDS regardless of time staying or participation.
- You may bring a cake, presents, plates, napkins, and eating utensils only. Food and drink packages are available for purchase or can be bought separately at the concession stand. NO ice chests.
- All guests are welcome to stay at the end of the rental but must exit the pavilion area.
- No affixing of any items to picnic tables, pavilion posts, concrete, canopy or trash cans.
- All AQUA PARDS rules and regulations will apply to the pavilion rentals.
- Party Host can arrive 15 minutes early to set up and decorate the party area. Glitter and small-sized decorations are not permitted.

## RAIN OUTS:

- If the weather gets bad during your scheduled party time and there is a RAIN OUT\*, the following rules will apply:
  - o If rain out occurs within the first hour of your party, a full refund will be given.
  - o **2 hour Rental:** If rain out occurs after the first hour, \$25 will be refunded.
  - o **Full Day Rental:** If rain out occurs after the first hour, your refund will be prorated based on the amount of time used before the rain out.
- A RAIN OUT occurs when AQUA PARDS has to close the facility for the remainder of the day due to inclement weather or other unforeseen aquatic circumstances. This does not include temporary closing due to lightning or other conditions.
